**COUNSELING & ADMISSION NOTIFICATION**

Candidates will be provisionally selected for admission into AICTE approved Diploma in Advanced Die and Mould Making and Diploma in Advanced Mechatronics and Industrial Automation courses for the session 2025-26 based on merit in MSME Diploma CET-2025 conducted by Andhra University on 11.05.2025. Candidates must meet all the prerequisites outlined in the notification and guidelines in order to get admission into the courses.

Counseling for the selected candidates will be conducted at MSME TC , Visakhapatnam. The seat will be allotted as per the choice of the candidate for 3 years Diploma in Advanced Die and Mould Making (DADMM) and Diploma in Advanced Mechatronics and Industrial Automation (DAMIA), while counseling on merit basis. Seat allotted for DADMM or DAMIA course at the time of counseling shall be final and no further request for change shall be entertained. Selection list of 132 nos will be made as per the reservation criteria (Gen-30,OBC-16 EWS-6, SC-9, ST-5) in each course. Reservation shall be made for candidates belonging to Scheduled Castes/ Scheduled Tribes as per rules of the Centre.

For vacant seats of SC/STs will be transferred to OBC and General Category as per AICTE norms

- 10.For admission to the courses the UR, OBC,and EWSs candidates should make online payment/DD of Rs 27,200/- (Rupees Twenty seven thousand two hundred only) towards the First Semester Fee and Rs.20000 Per subsequent semesters & SC&ST candidates Rs 7,200/- (Rupees seven thousand two hundred only) at the time of joining

12. Mother Bank Account pass Book first page.

The hostel seats (20 No Boys and 20 Girls) will only be allotted on distance basis.
